## Trip Cancellation and Trip Interruption

Remember to:

- 1. Keep all original invoices and/or receipts for payment and confirmation of your coverage in a safe place.
- 2. Keep your Summary of Coverage with you at all times during your covered trip.
- 3. Read *your* Summary of Coverage carefully.
